



TRUST IRREVOCABLE The Trust created by the Author of the Trust

is not and shall not be revocable at the instance of the Author of the Trust or by his successors at any time under any circumstances.

BOARD OF TRUSTEES :

- 7. The Author of the Trust will also be a Trustee for life and manage the affairs of the Trust. He further has the right to appoint other Trustees in addition, not exceeding four in all. These 5 initial Trustees, will be known as Board of Trustees.
 - 8. The Board of Trustees by a majority vote of not less than 3/4th of the to the total number of Trustees may co-opt any person as a Trustee. All Trustees so appointed by the Author of the Trust as also those co-opted shall hold office for life and are entitled to resign when they so choose. 11. MEETINGS OF THE BOARD OF TRUSTEES :

- 12. The Board of Trustees shall meet from time to time as and when necessary to transact the business of the Trust. There shall, however, be at least four meetings in a calendar year.
